2023 Budget Presentation



Major Points To Consider

SUMMARY

- 2.29% Local tax levy increase from 2022 to 2023 (\$228,528)
- Includes the absorption of all mandatory contractually obligated collective bargaining agreement (Union) increases as well as a 15% increase (\$170,000) in pension obligations
- Funds \$112,000 of Police retirement unused time payments
- Does not reduce the level of municipal services offered or reduce staffing
- 99.14% collection rate for 2022 helped reduce the 2023 Reserve for Uncollected Taxes appropriation by \$250,000
- 2022 surplus generated exceeded amount used to fund the 2022 budget by \$338,050 (\$1,298,623 vs. \$960,573)
- Surplus Balance 12/31/22 = \$2,614,393 Surplus Utilized in 2023 budget = \$1,600,000 Balance remaining = \$1,014,393

BUDGET IMPACTS


- COVID-19 effected revenues still include Court Fines
- Stagnant or minimal increases in State Aid for the last <u>9+ years</u>
- Pays off 1/5 (\$53,767) of the COVID-19 Special Emergency and 1/5 (\$36,000) of Tropical Storm Ida Emergency
- As introduced, this budget Includes the utilization of \$435,000 of American Rescue Plan Funding (ARP) as revenue loss replacement

OTHER IMPORTANT DATA

- The Borough is confident that it will generate additional sizeable ratables from pending new construction and upgrades to existing under-performing properties currently petitioning before its Land Use Board
- Total Ratables: **2023** = \$966,630,958 **2022** = \$964,543,799 **Increase** of \$2,087,159
- Local, School and Library Levies are Actual County Tax Levies Are Estimates




So, what do you get for the municipal portion of your taxes? For **2023**, the municipal and library portion of the tax bill for an average home valued at **\$317,092** will be **\$3,494**. For this amount, residents will receive the following services and programs:

- Garbage & Recycling Pickup
- Road Plowing & Street Maintenance
- Recreation & Park Maintenance
- Police Department & Crossing Guards
- Fire & EMS Services
- Sewage & Water Treatment
- Health & Human Service
- Senior Citizen Services
- Administration, Finance, Elections, Records
- Construction, Zoning & Planning (Land Use)
- Road resurfacing projects
- Sewer and other Infrastructure Improvements
- Safe Playgrounds & turf fields

Final Comments

Both myself, the Borough Administrator and the Finance Committee feel that this budget proposes a fair increase in the Municipal Tax Levy considering the negative impact that COVID-19 has had on the Borough's finances over the past 2 years as well as the current state of inflation in the economy. It is in line with increases authorized over the past several years and *does not reduce any services* that our taxpayers are accustomed to and *does not jeopardize staff levels* which many municipalities have had to resort to.

This is the ONLY part of your tax bill that the Mayor & Council control.

Final Comments

On average, each property will contribute \$3,494 per year to finance all Borough operations, including the Library, for the entire year 2023 (not including School or County tax levies).

To put this in perspective, in February 2023, the website "Moneyzine.com" reports that the average price of a pack of cigarettes in New Jersey is currently **\$9.22**.

Smoking 1 pack per day will cost you more than \$3,300 over the course of a year, and over \$6,700 if you smoke 2 packs per day!!
