MAYOR'S REPORT

The Mayor reported that there will be a meeting to go over plans for the new 8^{th} Street Bridge on Monday from 4-7p.m. at the Civic Center.

The Mayor advised that last Thursday the Mayor himself and the Borough Administrator went to a meeting at the New Jersey Transit. It was brought to their attention the lack of enthusiasm with the way it was handled. Safety issues were not properly addressed.

The Mayor reported that he is receiving complaints about the condition of the Rail Road crossing at Paterson Avenue.

The Mayor stated that he is in touch with our neighboring town of Garfield about the Bounty Program.

The Mayor reported that he attended the League of Municipalities Mayor's Association about a bill for the lack of continued increases in financial support. A 302 which tries to get funds back to the municipalities. By 2021 this would bring back the funding back to 2008 levels but took the control of the funds out of the local hands.

The Mayor commended the entire Council on supporting a zero tax increase.

The Mayor advised that he wants to establish a Committee to look at the issue of establishing a Police Monument near the Liberty crossing.

The Mayor advised that the Memorial Day Parade will be next Monday. It will not be long in length. The dedication of Union Blvd. as the Hartman Tursick Veterans Boulevard.

The Mayor advised that this upcoming week planting near the monuments with the Women's Club help will begin.

The Mayor stated that as a town Historian, he would like to put a lot of the pictures that are in storage on the walls of the buildings.

BOROUGH OF WALLINGTON COUNTY OF BERGEN, NEW JERSEY RESOLUTION NO. 2016 - 72

Support to Deny Parole for Christopher Righetti.

WHEREAS, on August 31, 1976, Kim Montelaro, a resident of New Milford, Bergen County, then 20 years old, was forcibly abducted, brutally assaulted and murdered by repeat offender, Christopher Righetti; and

WHEREAS, Christopher Righetti, Prisoner # 59431, is currently incarcerated for the killing of Kim Montelaro; and

WHEREAS, Christopher Righetti has gone many times before the Parole Board of Northern State Prison. His release was denied each time, as the parole board found that Christopher Righetti was unwilling to take responsibility for abducting, assaulting and murdering Kim Montelaro; and

WHEREAS, Christopher Righetti has never shown any remorse for his crime and has made no substantial progress in addressing the issues that led him to murder Kim Montelaro and has demonstrated a substantial risk for recidivism; and

WHEREAS, Kim's family should not be made to relive this horrible crime every few years when there is a parole hearing. They are forced to travel long distances from their current residence in Florida each time there is a parole hearing for their daughter's killer. They continue to suffer unnecessarily on Christopher Righetti's account; and

WHEREAS, in addition to the efforts of the Montelaro Family, the Borough of Wallington hereby supports the position that Christopher Righetti should not be granted parole and should serve out the full remainder of his life sentence. If a future eligibility date is set, we urge the Board to select a date at least 35 years from now. The abduction, rape and murder of an innocent young woman is a serious crime that demands justice; and the family of Kim Montelaro should be given the peace of mind of knowing that their daughter's murderer will remain behind bars for the rest of his life, as ordered by the court.

NOW, THEREFORE, BE IT RESOLVED that the Borough of Wallington hereby abides by the conclusion that Christopher Righetti be denied parole and be made to serve out his life sentence, otherwise this creates a grave injustice to the family of Kim Montelaro as well as to society.

BE IT FURTHER RESOLVED that a copy of this resolution shall be sent to the Bergen County Police Chiefs Association, the New Jersey PBA, the Office of the Bergen County Prosecutor, Keep NJ Safe, and-to Chairman James T. Plousis of the New Jersey State Parole Board.

RESOLUTION AUTHORIZING THE SETTLEMENT OF A TAX APPEAL AND AUTHORIZING THE EXECUTION AND DELIVERY OF A STIPULATION OF SETTLEMENT TO BE FILED WITH THE TAX COURT OF NEW JERSEY

WHEREAS, Wallington Medical Plaza, LLC. has filed a tax appeal with respect to the assessed valuation of the real property commonly known as 42 Locust Avenue, Block 40, Lot 1, located within the Borough of Wallington; and

WHEREAS, Wallington Medical Plaza, LLC the Mayor and Council of the Borough of Wallington, County of Bergen, has determined that it is in the best interest of the citizens of the

Borough of Wallington to enter into a settlement agreement in full and final settlement of the tax appeal filed by Wallington Medical Plaza, LLC; and

WHEREAS, the Mayor and Council has received the advice of its Special Tax Counsel with respect to this tax appeal. The Special Tax Counsel for the Borough of Wallington has represented that he has made such examination of the value and proper assessment of the property and has obtained such appraisals, analysis, and information with respect to the valuation and assessment of the property as he deemed necessary and appropriate for the purpose of enabling him to enter into this Stipulation and to fairly advise the Mayor and Council of the Borough of Wallington of the consequences of the settlement and the possible outcomes if the appeal proceeded to trial. The Special Tax Counsel for the Borough of Wallington also represented that he consulted with the assessor of the Borough of Wallington and that he has concurred with the settlement;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Wallington does hereby make the following findings:

- a) that it is in the best interest of the Borough of Wallington to reach an economic and businesslike resolution of the tax appeal for calendar year 2014, 2015, and 2016 filed by Wallington Medical Plaza, LLC with respect to the real property located at 42 Locust Avenue, Block 40, Lot 1, Wallington, New Jersey;
- b) that the proposed settlement will result in an assessment at the fair assessable value of the property consistent with assessing practices generally applicable in the taxing district as required by law;
- c) the terms of the tax appeal filed by Wallington Medical Plaza, LLC. that the Mayor and Council is authorizing its counsel to settle are as follows:
