HEARING OF CITIZENS

Mr. Andrew Donaldson of Jordan Avenue complained about Prime Motors creating (100 - 120) decibles) of noise. Mr. Donaldson has a two family house and his tenant is leaving because of the noise. There are tanks of high octane gasoline stored on the promise.

The Mayor stated that Monday night Mr. Sobczyk came and played a recording of the noise. Action was taken immediately. The Mayor instructed the Police Department, Building Department and Fire Prevention.

Mr. Chirlo of Jordan Avenue complained about the trucks coming in at all hours, trailers running all night while it was supposed to be antique cars only.

The Mayor responded that we will be sure that there is a happy medium.

Mr. Wood continued to elaborate on the issue. The Company has a dymo machine for cars.

Mr. Gregory Zagaja of Spring Court added that he heard the noises and was wondering what it was. Everyone was echoing their concerns. Mr. Zagaja thanked everyone for joining this Council Meeting. Revolutionary thinking is needed. Look for your leadership. This town cannot afford another Jasontown. We cannot afford cross traffic opening it up from Mt. Pleasant to Main Avenue. The CPI index has been in the negative. Poor people are in the middle. Fire Company 202 will need a new engine. The holiday parade is good for the town. We need that new vehicle, it's rotted through. We need to start this process immediately. We need to think outside the box. Mr. Zagaja Congratulated Councilman Rachelski and Androwis, we needed this change 8 years ago. Property taxes skyrocketed. It needs to stop.

Ms. Brenda Kapusta of Alden Street stated that the rumors are to buy a lot of equipment and then out source it.

The Mayor responded that we have set- up committees to address the issues. Each Committee has their jobs to do. We are taking small steps but they are big. This town will be seeing big things happen.

Ms. Brenda Kapusta stated that the house next door to her does not have a driveway and they are using her driveway. When can we control that house and when can we control the parking.

The Mayor responded that hopefully the parking sticker program will help with this issue. If it can work in Garfield and Lodi it can work here.

Ms. Helena Plaskon of Roehrs Drive stated that she spoke to the President of the Hackensack River Keeper asking for \$1,500.00.

The Mayor asked Ms. Plaskon to get the information.

Ms. Plaskon also stated that the next problem she has is her neighbors that have issues when she runs for council.

The Mayor responded that if Ms. Plaskon has a problem with her neighbors she needs to call the Police and work with them. Ms. Plaskon asked the Mayor if he could tell her how to run. The Mayor responded that anyone can run, that is your right.

Mrs. Palmer of Reservoir Avenue stated that her complaint over the last 30 years has been that her street is caving in on the even side. What are we waiting for? The Mayor responded that 46 Reservoir is his property. There seems to be an issue. It has been a problem. This will be referred to the engineering firm.

Councilman Kruk reported that there is a Home Run Community Grant that needs to be financed.

Councilman Kruk reported that he was advised of a dip on the bottom of Alden Street that needs to be addressed.

Councilman Kruk reported that the Opening Day at the Little League was on Saturday.

COUNCILMAN JOSEPH BRUNACKI

Councilman Brunacki reported that the Police Department handled 936 incidents last month, the accreditations are still ongoing.

Councilman Brunacki reported that the \$30,000.00 Safe and Secure Grant has been accepted.

Councilman Robie reported that the first meeting was held. We are doing this to help disabled people in town. We have money in the account that needs to be set up. We need to know who are the disabled and we need everyone's help for this.

COUNCILMAN KHALDOUN ANDROWIS

Finance

Councilman Androwis reported that the budget was introduced last month. Councilman Androwis advised that he sent an email this morning to the Auditor and he received an email back from the Auditor with using more surplus in the budget. This will help our homeowners. If we are more generous it can be more to come about it. Will sit down and discuss in further.

Water

Councilman Androwis is proposing to move one of the DPW salaries from the water department to the general budget. This will bring relief to the home owners. These things are possible. My taxes went up over 23%. When we ran for election, a lot of people wanted a change. We need to think outside the box. It will help our residents. Before they move out.

Capital Improvement

Councilman Androwis advises that they need to meet after the budget is adopted. Alden Street is very, very bad. Hathaway Street – what is going on with this street?

The Mayor mentioned about street signs especially near Banas Bakery.

Councilman Androwis stated that he hopes that there are a lot of rumors. I work in a large financial company. I knows lot of things that are going on and things are being said for Political Gain. I hope we can work together.

MAYOR'S REPORT

The Mayor spoke about moving the projects forward. Spoke about Alden Street and Handicap Parking. Work is in progress.

Board of Education

The Mayor reported that a Committee was formed to look at Shared Services. We are taking small steps. A Porta John – sharing with the Board of Education.

We are talking to State legislators about help.

Library

The Mayor reported that the monthly meeting was today.

The Mayor reported that 1300 people used the library in March. We have different programs going on.

The Mayor stated Assembly Bill 302 adds money from the energy resources to the municipalities but it seems like the Government's office stated that then the flat aid will get lowered.
