## **COMMITTEE REPORTS**

### **COUNCILMAN ROMAN KRUK**

Councilman Kruk advised that as fall sports are coming to an end. Winter sports are starting. The Trunk or Treat Program will be next week at the Little League at 5:00p.m. Last week the Administrator, Councilman Kruk, Mr. Dynes reviewed the plans for Crescent Road. At this point they are finalizing the plan.

Councilman Kruk advised that he spoke with the ladies at the Borough Clerk's office about our website. Councilman Kruk also spoke to the School about theirs.

### **COUNCILMAN JOSEPH BRUNACKI**

Councilman Brunacki reported that the Police Department handled 1083 incidents last month. Councilman Brunacki advised that the drop off zones for the schools are now marked.

Councilman Brunacki reported that after earlier discussions with the Bergen County Sheriff Department about truck traffic on Wallington Avenue resulted in 73 tickets being issued on Wallington Avenue.

Councilman Brunacki reported that Lt. Michaels is retiring November 1<sup>st</sup>. Councilman Brunacki thank Lt. Michaels for his service.

### **COUNCILMAN EUGENE RACHELSKI**

#### **Under DPW**

Councilman Rachelski advised that the DPW is supporting the EMS Department. Councilman Rachelski reported that general maintenance is being done including cutting grass, changing water meters. The DPW Department is also involved in cutting trees. The number of trees cut increased. The DPW Department is also involved in driving the Senior Bus.

#### **Under Code Enforcement**

Councilman Rachelski reported that several cases are being prosecuted. One of the Code Enforcement officers is very active.

#### **Under Budget**

Councilman Rachelski reported that they had the budget review meeting. The usage of gas is 40% higher than last year. Council President responded that it could be the added vehicles. Transparency should be there. Accountability by all departments.

### **COUNCILWOMAN SHARON ROBIE**

Councilman Robie wished all candidates the best of luck on the elections.

#### **Under Board of Health**

Councilwoman Robie reported that active inspections are being done. Councilwoman Robie reported several dog violations.

Councilwoman Robie advised that the Child Health Care Conference had 11 attendees.

Councilwoman Robie advise that the babysitting clinic is ongoing. The Handicap parking sticker is ongoing too.

### **Board of Education**

Councilwoman Robie advised that the “Hidden in Plain Site” presentation was one of the best and informative programs. A great resource to find drugs among our kids.

### **Access for All**

### **COUNCILMAN CHRISTOPHER SINISI**

Councilman Sinisi advised that we are working on the Handicap Parking Ordinance with the Board of Health.

### **COUNCILMAN KHALDOUN ANDROWIS**

#### **Finances**

Councilman Androwis advised that the Finance Committee asked for a meeting. The CFO provided the data necessary for the budget. Reviewed the Budget items with increases over \$10,000.00. The Finance Committee met for over 40 hours a week for several months. The Budget was raised “0” on the local level. Passaic Valley Water increased the average of 4% but we moved the work force to the general budget. A good thing for the residents.

#### **Capital Improvement**

Councilman Androwis advised \$60,000.00 was spent on Fire Department and EMS. Some of the money that was left was used on the Fire Department and EMS equipment.

Councilman Androwis advised that the Capital Improvement needs to be increased. The budget for repairs needs more money. Next year we need to put \$120,000.00 into Capital Improvement.

Councilman Androwis advised that Dankhoff Avenue was blocked by the garbage truck during school session.

Councilman Rachelski reported that they are trying to maintain a healthy surplus. There is not much money in the surplus.

### **COUNCILMAN CHRISTOPHER SINISI**

#### **Under Fire Department**

Councilman Sinisi advised that we received a turn down letter for the SAFER Grant.

Councilman Sinisi advised that the EMS answered 104 calls last month. The EMS answered a call in Hoboken. We need to look at emergency access to the train station. We need to look at the future. Need to work towards bettering the future.

Councilman Sinisi advised of the second reading for the EMS Ambulance.

#### **Under Personnel**

Councilman Sinisi authorized Borough Administrator to call for a list for Police Officers.



### **Shade Tree Commission**

Councilman Sinisi advised that \$3,250.00 was spent on Aspen Tree Service for emergencies. The DPW is working hard on these trees.

### **Under Courts**

Councilman Sinisi reported that we are looking at different possibilities.

Councilman Sinisi advised that the Senior Bus must be replaced. There are no grants available. Councilman Sinisi reported that the Fire Houses need generators. Each Fire House was looked at. The cost would be \$176,000.00 for all the buildings. Soil remediation is being done at the 4-H property.

Councilman Sinisi stated that Lt. Michaels started out in the County and rose through the ranks. The Police Department needs to recognize the people that work for the Borough.

**WHEREAS**, the governing body of the Borough of Wallington has determined that certain procedures need to be established to accomplish this policy

**NOW, THEREFORE BE IT RESOLVED** by the Mayor & Council of the Borough of Wallington, County of Bergen, State of New Jersey, that:

**Section 1:** No official, employee, appointee or volunteer of the Borough of Wallington by whatever title known, or any entity that is in any way a part of the Borough shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough's business or using the facilities or property of the Borough.
