WHEREAS, pursuant to N.J.S.A. 40A:4-41, a municipality must include an appropriation for "Reserve for Uncollected Taxes" in its annual budget where less than 100% of current tax collections may be and are anticipated; and

WHEREAS, receipts from the collection of taxes levied or to be levied in the municipality and payable in the fiscal year shall be anticipated in an amount which is not in excess of the percentage of taxes levied and payable during the next preceding fiscal year which was received in cash by the last day of the preceding fiscal year; and

WHEREAS, if tax appeal judgments of the county tax board pursuant to R.S. 54:3-21 et seq. and/or the State tax court pursuant to R.S. 54:48-1 et seq. result in tax reductions for the previous fiscal year, the governing body of the municipality may elect to calculate the current year reserve

for uncollected taxes by reducing the certified tax levy of the prior year by the amount of the tax levy adjustments resulting from those judgments; and

WHEREAS, Sheet 22 of the Borough's Annual Financial Statement for the year 2015 reflects reductions due to tax appeals of \$12,936 which when reduced from the 2015 tax levy results in the 2015 tax collection rate being 98.05 percent; and

WHEREAS, the election of this choice to calculate the "Reserve for Uncollected Taxes" for the 2016 municipal budget shall be made by resolution approved by a majority of the full membership of the governing body prior to the introduction of the 2016 municipal budget pursuant to N.J.S.A. 40A:4-5.

Building and Grounds

Recreation Team is outstanding and the new additions complement each other.

Councilman Kruk reported that the Spring Baseball is in full swing.

Councilman Kruk advised that all coaches will have to be trained for AED/CPR and Concussions Recognition.

Councilman Kruk reported that the Wallington Jr. Cheerleading Team received honors for their participation in the Jr. Cheerleading Competition in Virginia Beach. Councilman Kruk thanked their coach.

Councilman Kruk congratulated Lynda Branick on her retirement.

COUNCILMAN JOSEPH BRUNACKI

Councilman Brunacki congratulated Lynda Branick on her retirement.

Councilman Brunacki thanked Mr. Barone and School Officials for their involvement in the Student Government Day.

Councilman Brunacki reported that the Police Department handled 779 incidents last month.

Councilman Brunacki reported that the accreditation is continuing.

Councilman Brunacki reported that he contacted the Bergen County Police about the Wallington Avenue traffic and weights and measurements team.

The Mayor made a comment that the closing of the 8th Street Bridge will make it worse.

Councilman Brunacki reported that the Little League Opening Day will be on April 16 (rain date – April 17)

Councilman Brunacki reported that the Pulaski Memorial Parade Sashing will take place on April 23.

COUNCILMAN EUGENE RACHELSKI

Councilman Rachelski reported that the DPW Department performed the following during the month: The EMS Department answered to 29 calls; Flushed Sewers; Performed Fleet Maintenance; Replaced Water Meters; Finished the Bicycle Safety Grates Replacement.

Code Enforcement/Building

Councilman Rachelski reported that the rates for fine increases were reviewed.

Councilman Rachelski reported that the Code Enforcement interviews will be handled by the Personnel Committee. Illegals will be handled by Richard Cedzidlo, Esq.

Councilman Rachelski reported that he met with the Garfield City Officials who have the best system in regards to the Parking Stickers. This will be a huge project to generate a database. It will start on January 1, 2017. Anticipated start-up cost of \$65,000.00.

COUNCILWOMAN SHARON ROBIE

Councilwoman Robie thanked Lynda Branick for the years of service.

Councilwoman Robie reported that she is working with the Board of Health for increases in Health Department fees.

Councilwoman Robie spoke about a program to teach kids to baby sit and new legislation to lower the lead limit for children.

There was a discussion on the Zika Virus.

Access for All

Councilwoman Robie reported that they had a meeting with various neighboring town representatives to learn more about helping people. Any help will be good in identifying people who may need assistance.

Safety

Councilwoman Robie reported that she attended her first Safety meeting with the new group. Councilwoman Robie stated the insurance Agency will guide people with on-line Computer training classes.

Board of Education

Councilwoman Robie reported that she read in a newspaper that 95.92% students graduated from High School. South Bergen Joint Venture helps the school district.

COUNCILMAN KHALDOUN ANDROWIS

Councilman Androwis stated that as the town Auditor mentioned \$400,000.00 was used in Surplus – 3 cents increase. The average home assessed at \$311,000.00 will increase \$94.90 per year. We are lucky we only have a \$1.3 million Surplus but by 2018 we will need more surplus. Once the Farmland Site is developed it will help the situation. In November of 2015 Councilman Androwis and Councilman Rachelski walked door to door and heard people complain. Councilman Androwis stated that he needs to take care of our residents.

Capital Projects

Councilman Androwis reported that the meeting will take place in the next few weeks. Councilman Androwis reported that the street signs are fading – need to address the issue. Councilman Androwis congratulated both Lyndas.

MAYOR'S REPORT

The Mayor congratulated Lynda Branick on her last day.

The Mayor mentioned that on Memorial Day there will be a dedication on Union Blvd. to Hartman/Tursick Veterans Way.

The Mayor advised that the gazebo will be approved on Monday night's meeting.

The Mayor advised that the street scape plan will need to be scaled down project.

The Mayor stated on April 21st he will be honoring the Cheerleading Squad.

The Mayor advised that High School student Earth Day clean-up will take place on April 22nd.

The Mayor has been in contact with Congressman Pascrell's Office.

Library

The Mayor reported that the library had 1500 attendees last month.

The Mayor is working on plans with the DPW Department.

The Mayor asked for the friends of the library to look for donations in the construction.

The Mayor stated that he would like to do Youth Government days. Youth Advisory Board from September's meeting, need keep ideas going and inform us of new ideas.

The Mayor stated that the one last thing that bugs him about the State Aid is the numbers have been the same for the last eight years we need to speak up to the government. The Mayor advised that a letter needs to be sent out to the Governor or State Senate asking what is going on. The New President Senate Speaker, had a Special Election which cost \$25 million could have waited one month. The Bridge Gate costs need to fight these costs, we could have used these Founds – not fair.

The Mayor said that the one last thing he wanted to talk about is the EMS and Fire Department and about sufficient supplies of people. The Mayor stated that he attended a seminar in Atlantic City Convention. It was loaded by paid people looking for work.

The Mayor stated that the Fire Department training is for six months now, it used to be six weeks. Emergency Medical Technician side is even more ridiculous, it's a 6 month training and it used to be 84 hours.
