BOROUGH OF WALLINGTON COUNTY OF BERGEN, NEW JERSEY RESOLUTION NO. 2015 -71

RESOLUTION URGING INTERVENTION OF CONGRESSIONAL DELEGATION OF THE CLEAN-UP AND RESTORATION OF THE PASSAIC RIVER

WHEREAS, the Lower Passaic River Study Area (LPRSA) - 17.4 miles of the Lower Passaic River from Dundee Dam to Newark Bay - has been designated a Superfund Site by the USEPA, is one of largest sediment sites in the nation and has been studied since 2004; and

WHEREAS, the USEPA released its Focused Feasibility Study and Proposed Plan in April 2014 which recommended a bank-to-bank dredging and capping of 4.3 million cubic yards of sediment in the lower 8 miles of the Passaic River (Belleville to Newark Bay), the largest environmental dredging project in the history of the USEPA; and

WHEREAS, the USEPA estimates the project would take five (5) years (four (4) years of dredging and one (1) year of capping); and

WHEREAS, during the public comment period conducted by the USEPA (April 2014 - August 2014) a number of elected officials and key stakeholders raised a number of concerns and asked specific questions; and

WHEREAS, the Borough of Wallington agrees with a number of the concerns raised and questions asked during the public comment period, specifically issues such as project approach, cost, schedule, duration, local disruption, impact on economic development; risk reduction, recontamination etc.; and

WHEREAS, the USEPA has stated its intention to release a Record of Decision (ROD) relative to the Proposed Plan by the end of 2015 with the Agency's decision on the remedy for the lower 8 miles of the Passaic River; and

WHEREAS, as the process is currently configured, the Borough of Wallington has serious concerns that, absent intervention by members of the Congressional Delegation representing the LPRSA to urge a settlement between the USEPA and the Potential Responsible Parties (PRPs),

the USEPA's ROD will be challenged in court and litigated for many years further delaying any meaningful restoration in the Passaic River;

THEREFORE BE IT RESOLVED that through this Resolution, the Borough of Wallington respectfully requests that US. Senator Menendez, US Senator Booker, Congressman Sires, Congressman Pascrell and Congressman Payne intervene to urge a settlement between USEPA and the PRPs that avoids further litigation, prevents further delay of clean-up efforts, and leads to immediate and meaningful restoration efforts in the Passaic River.

BOROUGH OF WALLINGTON COUNTY OF BERGEN, NEW JERSEY RESOLUTION NO. 2015 -72 SUPPORTING THE TRANSPARENT TAX ACT OF 2015

WHEREAS, Assembly Bill No A-4325 supplementing chapter 4 of Title 54, R.S. 54:4-65 and designated the "Transparent Tax Act of 2015" is being considered for adoption by the New Jersey State Assembly; and

WHEREAS, the amendment would permit the local jurisdiction to print separate tax bills to each taxpayer, one showing the amount of property taxes due and payable for municipal tax purposes, the other shall state the amount of property taxes due and payable for county purposes, school purposes, fire district purposes, and for the purposes of any other special district on behalf of which the municipality collects property taxes; and

WHEREAS, both bills shall include a brief tabulation showing the distribution of the total amount to be raised by taxes; and

WHEREAS, A-4325 would require the municipal tax collector to send notice of the pro rata share, if any, of the property tax appeal refunds paid by the municipality during the tax year to the county, school districts, and fire districts for inclusion in their annual budgets; and

WHEREAS, in the following tax year in which the refunds were paid, the municipal tax collector is then required to deduct the applicable pro rata share of the property tax refund from the amounts to be paid to the county, and each school and fire district; and

WHEREAS, these amendments, if adopted, will assist the general public to understand the tax bill, the structure of the taxes, and the level of support for each agency, and will further provide a more equitable structure to share the obligation of paying approved tax appeals as the title states, creates transparency in the tax supporting local assessments.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Wallington, County of Bergen and State of New Jersey hereby supports Assembly Bill A-4235

amending Title 54:4-65 and urges the Legislature to approve and pass the bill for the reasons expressed herein; and

BE IT FURTHER RESOLVED that a copy of this Resolution be sent to the members of the New Jersey State Assembly, the members of the New Jersey Senate, and the Governor of the State of New Jersey, the New Jersey State League of Municipalities and the Municipal Clerk's Association of New Jersey.
