COUNCILMAN JOSEPH BRUNACKI

Under Board of Health

Councilman Brunacki Board of Health Reorganization meeting was held on January 17th. New board members were welcomed. New programs were offered.

COUNCILMAN EUGENIUSZ RACHELSKI

Under Finance

Councilman Rachelski advised that he received a tax revaluation from Bergen County to be done by October 1, 2018. Councilman Rachelski requested the Mayor to join the February 7th meeting in the County. This is something that needs to be done. Spoke to someone at the Board of Taxation about time need to change the scope of the work. Need to track that important information with the school. It is a great opportunity to connect to everyone and all departments. Councilman Olkowski asked when was the last one done.

Councilman Rachelski answered – new tax revaluation 2014 but not done well.

Councilman Olkowski stated – this years ago only. Go to the next Board of Freeholder Meeting. Councilman Rachelski stated – we need to do something.

The Mayor stated – the time frame is three years.

Councilman Rachelski stated – payment over five years.

Councilman Rachelski stated that we received a check for electrical bills of \$15,000.00 for the money back from the landscaper.

Mr. Rachelski we are in the process of hiring a forensic auditor to recover \$350,000.00 in water. We need to set up a claim with the insurance carrier.

We are looking at Sharing of Court with Carlstadt. Mr. Rachelski stated that last Friday I attended a basketball game very successful event.

COUNCILMAN KHALDOUN ANDROWIS

Under Police

Councilman Androwis reported that the Police Department issued 180 summonses and handled 10 arrests. They are doing a phenomenal job. We will ask the Borough Attorney to ban the sale of Marijuana in the Borough.

Under Capital Project

Councilman Androwis advised that the Borough Engineer is looking at the grants for Spring Street and Spring Court.

Jacob Street and Franklin Avenue will be bid January 18th.

A resolution is in place for Main Avenue and Midland Avenue.

The roof and window replacement bid will be done in late January or early Friday.

The Generator bid will be done on January 18.

There will be more details on the CDBG Grant for King Street on February 6.

Under Shade Tree Commission

Councilman Androwis advised that the Aspen Company was awarded the cutting contract of \$14,750.00 at the last meeting. We are also getting other requests for tree trimmings.

COUNCILWOMAN MELISSA DABAL

Under the Website

Councilwoman Dabal advised that there was an office hick-up on the 2018 updates. We are working on the issue. It will be done by the end of January.

Under Library

Councilwoman Dabal received the first drawing from the Architect. We are looking at the questionable expenses listed in the expenses. New committees to question expenses.

Under Code Enforcement

Councilwoman Dabal advised that has been meeting with the two Officers and changing the reporting lines from Melfi to Tanderis.

The Mayor stated – next week we can meet with the departments.

COUNCILWOMAN WENDYSU IVANICKI

Under DPW

Councilwoman Ivanicki advised that she held a meeting with Mr. Dynes. Councilwoman Ivanicki reported that the DPW handled the following:

- Sewer Inspections
- Drove Senior Bus
- Water Main Breaks
- Snow Plowing
- New Handicap Signs
- New Carpet in the Civic Center

Councilwoman Ivanicki advised that she also discussed with Mr. Dynes the Service Call Sheets and a need for a software. He is happy about that. We are in the process of getting new equipment.

COUNCILMAN BRYAN OLKOWSKI

Councilman Olkowski passed out a copy of his report.

Under Recreation Board

Councilman Olkowski reported that the first meeting was the reorganization meeting. Mr. Nick Melfi was appointed President. Special thanks for Joe Brunacki for his years of service on the Recreation Board as President. He is now the Vice President. TJ Calabrese is the Treasurer and Dennis Graham is the secretary.

The Recreation Board is operating under a \$12,000.00 temporary budget until it is approved. \$3,000.00 was used in this budget to pay stipend for Mr. Popek to run the Basketball program. I went last Saturday to see how the program is running and there were many children and families in attendance. There is \$9,000.00 left in the temporary budget. About \$3,500.00 is expected to be used for the Easter Program. The Trust account has \$5,893.96 in the account.

Councilwoman WendySu Ivanicki announced her intention to resign from the Recreation Board. This means that Dariusz Wesolowski will replace Councilwoman Ivanicki and Doug Casteen will move up to Alternate #1. This means we need an Alternate #2. If anyone has suggestions, place let me know.

A fundraiser is being held entitled, "Paint the Night Away" It will be held on Friday, February 9, 2018 at Firehouse #201. The cost is \$40.00 per person. Art supplies will be provided but bring your own snacks. Hopefully this can be placed on the Borough Website for advertisement.

Under Board of Education

Board of Education updates on January 8, 2018 and January 22, 2018 meetings. Councilman Olkowski reported that the Wallington Public Schools has officially entered into litigation against the state of New Jersey requesting the state of New Jersey adequately fund our schools. According to Superintendent Albro Wallington Public Schools is underfunded by about 6 million dollars. Wallington taxpayers are making up the difference. See the article entitled, "These 10 NJ School Districts will battle the state on school funding" http://www.brennermade.org/2018/01/12/these -10-n-j-districts-will-battle-the-state-on-school-funding/ **This was also reported in the Star Ledger**

The Wallington BOE Policy entitled P&R 7441 Entitled "Electronic Surveillance in School Building and on School Grounds". This will require a memo of understanding for Police and Town to work together.

The Wallington Town Council Subcommittee met with the Wallington Board of Education Subcommittee on January 15, 2018. Councilman Olkowski, Councilman Dabal, and Councilwoman WendySu Ivanicki met. Board of Education Members Joe Smith, Bobby Ristovski, and Dave Pinto were in attendance from the BOE. The major goals of the Subcommittee's work are the following:

- a. Identify a site for a new school if it is deemed necessary.
- b. Reduce the number of children attending school in the district who do not live in the district.
- c. Renewal of Most Sacred Heart Lease.
- d. Explore opportunities for Special Education children.

Board of Education Member Tom Brynczka worked with other BOE members to develop a survey entitled. "School Development Survey" It is posted on both BOE and Borough websites. See article entitled, "Wallington asks resident: Do we need a new school?" https://www.northjersey.com/story/news/bergen/wallington/2018/01/20/wallington-asks-residents-do-we-need-new-school/1041146001/ **This was also reported in the Bergen Record**

The School Performance Reports are now online for public consumption. Student growth scores are lower than where it needs to be. Wallington has about 10% of its students who are chronically absent from school.

The Wallington Board of Education has created a School Referendum Projects Committee. This committee is dedicated to exploring the option if a new school should be built. The Wallington Board of Education is attempting to address some of the following questions posed by members of this council specifically:

- a. How will future enrollment impact school?
- b. How much space is needed for the school?

The Wallington Board of Education authorized the spending of up to \$9,600.00 to hire an architect to help determine the answers to these questions. The concern is that if the newly elected Governor of New Jersey intends to put money back into schools, the district needs to have a plan in place or may possibly be passed over.

We need a plan between the Borough and the Board of Education.

MAYOR'S REPORT

The Mayor wanted to go over few items.

The 8th Street Bridge is running on schedule. The Wallington Avenue will be repaved.

We need to discuss whether to hold off until the 8th Street Bridge is reopened.

The Mayor gave an example of money not spent well.

Under Fire Department

The Mayor stated that it has been quite. The Bergen County 200 Club has given a grant for a new Thermal Imaging Camera.

BOROUGH OF WALLINGTON COUNTY OF BERGEN, NEW JERSEY Mutual Aid Resolution No. 2018-54

WHEREAS, the police departments in Bergen County have a day to day responsibility to provide for the security of lives and property, for the maintenance and preservation of the public peace and order, and

WHEREAS, Law Enforcement Officials also have a responsibility to provide for preparedness against natural emergencies, such as floods, hurricanes, earthquakes, major storms, etc., manmade causes, civil unrest, and civil disobedience such as riot, strikes, jail or prison riots, train wrecks, aircraft crashes, major fires, ethnic disorders, riots, terrorist incidents and bombings, state and national emergencies, and

WHEREAS, the Bergen County Police Chief's Association has proposed a Mutual Aid Plan and Rapid Deployment Force to deal with these emergencies, and

WHEREAS, this Plan is adopted in accordance with the provisions of N.J.S.A. 40A:14-156, N.J.S.A. 40A:14-156.1, N.J.S.A. 40A:14-156.4 and N.J.S.A. App. A:9-40.6, and

WHEREAS, this Plan will provide a uniform procedure for the coordination of the requesting, dispatching, and utilization of law enforcement personnel and equipment whenever a local law enforcement agency requires mutual aid assistance from any other jurisdiction, both contiguous and non-contiguous, in the event of an emergency, riot or disorder, in order to protect life and property, and

WHEREAS, it is also recognized that the Wallington Chief of Police, in accordance with the provisions of N.J.S.A. 40A:14-118 and under the authority of the Bergen County Prosecutor, has the authority to assign officers to a Task Force, Rapid Deployment Team, or Regional SWAT Team operated in conjunction with the Bergen County Prosecutor's Office, and

WHEREAS, it is the desire of the Mayor and Council of the Borough of Wallington to participate in a Mutual Aid Plan and Rapid Deployment Force in accordance with the Plan as submitted by the Bergen County Police Chief's Association.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Wallington that the police Department of the Borough of Wallington, under the direction of the Chief of Police, cooperate with the Bergen County Police Chief's Association to create an Interlocal Services Agreement with all municipalities in the County of Bergen in order to put into place the Mutual Aid Plan and Rapid Deployment Force, and

BE IT FURTHER RESOLVED that a copy of the Resolution be forwarded to the County Executive, the Board of Chosen Freeholders, the County Prosecutor, and all municipalities in the County of Bergen.
