MAYOR READS HIS ANNUAL MESSAGE

As we embark on this new year of 2018, on behalf of the members of this governing organization I would like to wish all our residents, friends and neighbors a very happy and healthy new year.

As we begin this 124th year for the Borough of Wallington I would also like to thank all of our borough of employees for their hard work and dedication in keeping our town operating. I would also again wish to publicly thank Roman Kruk for his 6 years of service as Councilman and Sharon Robie for her 2.5 years as a Council member.

I welcome back Bryan Olkowski to the Council on being elected in his own right and thank him for allowing me to perform his oath of office and of course we welcome to the Council WendySu Ivanicki and wish her well in her new position as a Council member.

I truly hope that as a Council we can all work together to provide better services, solve our many and varied problems and move on progressively for a better future. We have many problems in our town in many different areas and I won't sugarcoat these problems. The decisions we make will affect everyone and each needs to be thought out carefully. I look forward to working with you all.

I plan this address to be brief due to being on the verge of losing my voice which might make you all very happy but I wish to touch on a couple of things.

We will continue our fight in securing more aid for our Borough from State and Federal Government. Really to get our fair and rightful share. I have fought through our Mayor's Associations to have our State Government raise the aid given to towns which has been a flat rate for 8 years and I have been warning everyone monies are drying up from the Federal Government such as Community Development and other programs and obviously we depend on those funds which have allowed us to do projects recently as Anderson Ave. paving curb and sidewalks and King St. sidewalks and curbs. It is a never-ending project in an older town such as ours but we are always trying our best.

We have continued to look into shared services with other towns and always look at what cost savings they can provide.

After many frustrating meetings regarding flooding issues I am working on a Mayor's group to form with all towns along the Passaic River from Paterson down to Kearny, taking in 4 countries to organize and lead in a strong voice to get the assistance warranted to alleviate these situations.

Our Code Enforcement, Building Department Fire Prevention and Health Department will be assembled shortly to work on a comprehensive plan to organize their working relationships and combat the illegal and dangerous housing and buildings that may exist in our town.

I have brought up a few times on the conditions of some of our Borough Buildings and the need to look into with careful planning if some of these existing buildings are worthwhile to keep putting funds into them. I truly hope we can get together a reasonable solution.

We are hoping to receive funds to continue the Streetscape Program and finish Union Blvd. to the church of the transfiguration and when we accomplish that we could look to other areas such as Locust Ave. since it is the most heavily traveled road in town by all.

We will be working on memorials to our Police Department and a tribute to 9/11 and Pearl Harbor to be erected at Liberty Park and we will also be working on Veteran's tribute banners along various streets in our Borough.

Many other programs such as the repaving projects will continue with priorities set as street condition.

We have many more issues that need to be worked on and I truly hope this council will bring ideas, suggestions from everyone together to find solutions. This Council cannot be run by one or dictated by me. It will need to work as a group to achieve success and I believe we can accomplish this.

One last item, next year our Borough will be celebrating its' Quasquicentennial "kwos-kwi-senten-ee-uhl" much easier said the 125th Anniversary. I will be appointing a committee to plan and execute a proper celebration of this momentous occasion and hope to bring our Borough together.

We are proud little Borough and all of us sitting here on the dais truly care for our community and try to do our best. When we fail on things we all fail together and when we succeed its' also together. It is not an easy job to serve and at times thankless but if you truly love our Borough you will work for the best solutions.
