Councilman Rachelski stated the Borough is entering a challenging year – financially. The costs are over one million. The next expense is the library. We are looking for grants.

We are waiting for a Water project. We received \$500,000.00 from back taxes. We just found out we owe \$460,000.00 in unemployment back taxes to the State. It is not a comfortable situation.

Councilman Rachelski stated we are being pressed to do a reevaluation at a cost of \$300,000.00. It is due, no balance in the Borough.

These are the challenges. Every penny counts. The CFO is great.

COUNCILMAN KHALDOUN ANDROWIS

Councilman Androwis spoke about Capital Projects. Pre construction meeting to televise, the sewer lines for Willow Avenue, Spring Street and Spring Court we need to look at maximizing the work. Councilman Androwis stated that he is looking to see if we can move Currie Avenue money to Morrissee Avenue and Jordan Avenue. We are working the Engineer. We are doing Jordan Avenue and Morrissee Avenue with grants.

Under Shade Tree Commission

Councilman Androwis reported that the committee met several times. We looked at the Ordinance. Councilman Androwis met with Ray Dynes and Aspen Tree. Mr. Androwis will also be meeting with the Engineer.

COUNCILWOMAN MELISSA DABAL

Councilman Olkowski explained the need for the funding. We are looking at this from a water loan. We have a 6 to 8 month window with the County.

Councilman Rachelski stated – the way the system works, we need to set an Ordinance. \$100,000.00 needs to be set aside. I worked several nights looking for funding.

Councilwoman Dabal stated – we are in agreement. It is a great project. The County is paying for the paving. We need to speak about getting a commitment from the County. Hold off for six to eight months.

Councilman Rachelski stated – it is a good project but we need to do it smart.

Councilman Olkowski stated – we have an opportunity.

Councilman Androwis stated – just to add interest rate is 1% at the water bank. Interest rate will save money.

Councilman Rachelski stated – we have \$5,000,000.00 to bond. We need to look at the big picture. Can we start charging for the sewer?

Councilman Androwis stated – the \$4,500,000.00 was incorporated with the \$9,000,000.00. There is no price tag for the safety of the residents. Water is important.

Councilman Rachelski stated – we want to do it right. Look at the big picture.

The Mayor stated – we were to write a letter to Bergen County asking if Capital has been set aside.
