MINUTES CAUCUS/WORK SESSION DECEMBER 11, 2018

Council President Rachelski called the meeting to order at 7:35 p.m.

Flag Salute and Invocation

Council President Rachelski read the Public Meeting Notice pursuant to the Sunshine Law

Roll Call: Brunacki, Rachelski, Androwis, Dabal, Ivanicki, Olkowski - present

Mayor Mark W. Tomko -absent

Borough Attorney Richard Cedzidlo-present

Borough Administrator Victor M. Polce –present

HEARING OF CITIZENS

Motion to Open the Meeting to the Hearing of Citizens by Dabal, Seconded By Androwis. Roll Call: Brunacki, Rachelski, Androwis, Dabal, Ivanicki, Olkowski

Kathy, a resident of Jordan Avenue, stated her concerns regarding the condition of the roadway on Jordan Avenue. Councilman Androwis provided information on future plans to repair streets in the Borough. He indicated that Jordan Avenue would be one of those roads. The resident also stated her concerns regarding yellow lines on Jordan Avenue. Councilman Rachelski answered that the Borough must comply with State Law.

Ms. Helena Plaskon of 86 Roehrs Drive questioned the ordinance for traffic on school streets and about the Do Not Enter sign on Alden Street and Mount Cedar Avenue. She requested changes to the ordinance. Borough Attorney Cedzidlo explained the procedure for ordinance adoption. Borough Attorney Cedzidlo stated that if he gets authorization by the Mayor and Council to make necessary changes to the ordinance, the first reading of the revised ordinance would be in January. Ms. Plaskon questioned the Mayor and Council on not answering her emails. Councilwoman Dabal and Councilman Rachelski answered Ms. Plaskon's concerns. Ms. Plaskon questioned the Borough's ability to control usage of the internet in Borough's Offices. Councilwoman Dabal stated that there is appropriate software is in place. Ms. Plaskon questioned the furnishing of Borough's Administrator office and not being able to sit down and raise her concerns. Councilman Rachelski and Councilwoman Dabal answered her question.

Motion to Close the Meeting to the Hearing of Citizens by Dabal, Seconded by Androwis. Roll Call: Brunacki, Rachelski, Androwis, Dabal, Ivanicki, Olkowski

Motion by Councilman Rachelski to enter into executive session for the purpose of discussing personnel matter, Seconded by Dabal. Motion failed due to Borough Clerk Baginski's request to have his Rice Notice presented during the open session. Borough Attorney Cedzidlo explained that nobody will be able to speak during the Rice Notice in open session.

Councilman Rachelski asked Labor Attorney Mr. Corrigan to present the Rice Notice to Borough Clerk Baginski, he also reminded everyone that there will be no open discussion. Labor Attorney Corrigan introduced himself and explained his task regarding Borough Clerk Baginski. Councilman Rachelski stopped Labor Attorney Corrigan and made a motion to have Deputy Borough Clerk Agnieszka Brynczka to take over recording of minutes, Seconded by Dabal Councilwoman Dabal. Mr. Baginski raised his concerns with regards to Robert's Rules and being in the executive session. Labor Attorney Corrigan remind Borough Clerk Baginski that it is not appropriate for him to make any comments and that he requested to remain in the open session. Borough Clerk Baginski stated his concerns regarding not being able to speak. Labor Attorney Corrigan presented his review of Borough Clerk Baginski's record of performance for potential illicit activity and failing to comply with the laws and regulations of the State of New Jersey.

- Borough Clerk Baginski repeatedly failed to comply with the Open Public Records Act, and due to his non-compliance, the Borough was obligated to pay the attorney's fees of over \$7,000.00.
- Borough Clerk Baginski failed to comply with the state law in preparation of meeting minutes.
- There was a determination regarding overtime that was not authorized based on an investigation by the State of New Jersey. Borough Clerk Baginski has not repaid the unauthorized payment that he received.
- There is evidence with respect of Borough Clerk Baginski double dipping regarding his cellphone. He has a cellphone paid by the Borough and in addition he is receiving a stipend for a cell phone.
- Borough Clerk Baginski failed to provide answers to a councilmembers request for information in regard to stipends.
- There was determination made that a business in town was receiving free electric and water. Water costs were over \$300,000 and electrical cost were over \$14,000, all of it under Borough Clerk Baginski's watch.
- Borough Clerk Baginski repeatedly refused to respond with information requested by councilmembers and required them to file OPRA requests which he is not complying with.
- Borough Clerk Baginski repeatedly acts without authority and is insubordinate to anyone who is a supervisor including an instance when he engaged in work place violence.
- There was a recent incident when Borough Clerk Baginski was tasked to deliver voter registration to the county office in Hackensack, he refused to perform this task unless he was driven to Hackensack. After being questioned why he is not performing his duties,

- he walked off the job being insubordinate and stating that he was sick. In doing so, he took fraudulent use of sick time.
- Most recently one of the businesses in town requested to make a presentation to let the
 public know what they were doing, and requested Borough Clerk Baginski to notify
 councilmember. Instead, the first notice came out from the Democratic Club on
 Facebook.

Labor Attorney Corrigan stated that he prepared tenure charges and there are procedures to be followed. His recommendation is to file the tenure charges which needs to be done by resolution. Borough Clerk Baginski asked if he has an opportunity to answer. Labor Attorney Corrigan stated that Borough Clerk Baginski will have opportunity to respond. He was invited to meet with Mr. Corrigan but he did not, he also had opportunity to have his attorney present. Furthermore, Borough Clerk Baginski will have the opportunity to respond during the hearing. Borough Clerk Baginski insisted on answering to Labor Attorney Corrigan's statements and read his statement. "Mr. Baginski believes this is all in retaliation for his past complaints against the council, his rights of privacy in the doctor's office were violated by borough administrator under the direction of the council, his rights to access to the public building, he was also locked out from his computer since Monday. "Labor Attorney Corrigan finished his presentation. If there are any questions they should be answered in the executive session due to attorney client privilege. Councilman Olkowski stated that he would like to ask a few questions in the executive session. Borough Clerk Baginski stated his objections to entering into executive session. Labor Attorney Corrigan answered his concerns.

Motion by Councilman Rachelski to have Deputy Clerk Agnieszka Brynczka to take over the minutes in the closed session, Seconded by Dabal.
