Ula Naslonski, 18 Union Blvd: Raised concerns on Parking in the area of Union BLVD. by the civic center. Councilman Rachelski exited the meeting and visually inspected the area. Resident Naslonski advised that she received a summons, and concerned about poor parking courtesy by neighbors. There are cars parked in such a way that take up multiple parking spots. Mayor Dabal advised that she spoke with Chief Imbruglia and Borough Administrator Hector Olmo about utilizing borough parking lots for overnight parking. She also advised that the transformer by her house is leaking. Councilman Rachelski returned, took pictures, and discussion took place on clarifying her concerns.

Janet Gurdak, 72 Halstead: Advised that "67 Halstead is a pig sty." A car has been consistently parked in the area where construction needs to take place. All caution signs have been moved, and the area is unsafe. Mayor Dabal advised that the house was unkempt for forty years, and for the first time the house is getting renovated due to her persistent follow up. This was part of her initiative of addressing "zombie homes." Borough Attorney, Richard Malagiere, advised that all

writs of eviction have been suspended reference executive order. Resident Gurdak advised that these people are not paying for anything and if she did the same thing there would be negative repercussions. Lastly, Resident Gurdak expressed concern over slip and fall accidents due to the lack of construction progress. Mayor Dabal stated in effect that it's the bank's responsibility, and progress is being made.

### **COMMITTEE REPORTS**

### **COUNCILMAN EUGENIUSZ RACHELSKI**

Looking into a few different options for the new Police Station, negotiations are ongoing. Working with Borough attorney and Councilman Sadecki on a few different ideas for low volume revenue generation for the latex property; Described the success of 120K positive cashflow reversal from 125 River Drive.

#### **COUNCILWOMAN SUSANNE PREINFALK**

Described plans for BOE and various dates that will answer questions and concerns. It appears at this juncture that it will be a hybrid in person and virtual instruction. No direction provided from Governor's office. Vaping ordinance is in effect. Library has been open since July 6; plexiglass barriers have been installed. The Mayor and Council put together an ad hoc food pantry for any residents in dire need as a result of COVID-19.

### **COUNCILMAN TOMASZ ORZECHOWSKI**

Thirty-Three properties were written up for the month of July. Councilman Rachelski made a point that between 2014 and 2017 only three properties were cited. Recreation will have a summer softball program to make up for cancelled softball in the fall. Recreation board is also looking to add additional sports.

#### **COUNCILMAN TOMASZ SADECKI**

Bid specifications for road program 2020 are being finalized. Conducted inspection of the latex property; There is a developing plan that is open for discussion for leasing options to generate revenue. Impressed with John Rebecky and the zoning board; Provided a high-level description of various zoning applications.

### **COUNCILWOMAN WENDYSU IVANICKI**

"It is with deep regret to announce the passing of Wallington Fire department Truck 1 Ex Chief Kenneth Gajda. Kenny joined the company in 1971 through 2015. Ken served as Chief in 1982 and was a life time member of the fire association. He was a legend in this town and will be truly missed. The funeral arrangements are Saturday 205 at Warner Wozniak Funeral Home."

The Wallington Fire Department has been conducting meetings and cleanups while maintaining social distancing. A presentation will be conducted by revenue guard to the Fire Chief and EMS Captain; This does not mean we are obligated to use Revenue Guard or will transition to a paid service. Raised concerns on the logistics of training DPW with tough books. Raised concerns that multiple projects went out to bid, approved and budgeted, but work has not started. Mayor Dabal asked what is the delay? A discussion took place on the various communications with approved projects, and the delays. Mayor Dabal reiterated that this is priority and needs to be done. Borough Administrator stated

that he followed up with contractor, and if they do not start the work, we will go back out to bid. Covid -19 is partly responsible for the delays.

#### **COUNCILMAN KHALDOUN ANDROWIS**

Wallington received the gold award. Information has been distributed about flash floods. There have been three lights replaced in the borough.

#### MAYOR'S REPORT

Spoke about the broken windows theory; Described various "zombie properties" and how property maintenance and building department wrote multiple summonses and letters to banks. These efforts caused the bank to invest money into houses and subsequently being purchased by families that added additional renovations. 160 violations warnings were sent to homes where 80%-85% that are largely non-home owner occupied. There appears to be a problem with transient activity along Wallington Ave. This has led to 8 additional cameras being placed near all the entrances to town and two of those placed in targeted areas on Wallington Ave.

### **ATTORNEY'S REPORT**

Asked to go into closed session to present the lease for 125 River Drive. Will talk about ordinance that's on for first read.

### **ADMINISTRATOR REPORT**

Spoke at a high-level of the price negotiation with Kearney Bank. There is an acquisition cost and supplemental costs necessary to bring the building up to code. A discussion ensued on various cost estimates of the property and necessary upgrades. We need to get an update from Brian Giblin, Esq, because we are not taking in enough money from applications to cover costs. Councilman Rachelski advised that this is a major issue. Borough Administrator advised that the ordinance needs to be changed. Borough Attorney advised that the numbers need to be updated, can't invade general funds to fund professionals. Mayor Dabal advised that we caught this last year, and this is something that was going on for many years and the tax payers were paying for major projects. There is an issue with leaking in the old building; A discussion took place on various issues and necessary repairs that need to be repaired starting with the roof. Covid-19 testing site was successful; Planning for another event in September. We applied for the bus grant and we may potentially receive two if we can justify need. A discussion took place on the ability to open parks and what the guidelines are for opening.
