COUNCILWOMAN SUSANNE PREINFALK

November 9, 2020 Board of Education voted to move to virtual instruction until after the new year. 13 employees and 1 resident received a flu shot at the flu clinic. Rabies Clinic had a total of 38 pets. Beatification committee is reporting that new signage is anticipated to be installed over the next two weeks. Through the NJ Library Bond Act, Wallington was awarded a grant totaling \$1.5M for the build of a new library. In conjunction with the \$500K bequeath this will result with a zero-capital expense burden to the tax payers. Councilman Rachelski advised that this has been going on since the late 60's and we finally had the right people to make this move forward. It is anticipated that construction will begin sometime next year. Mayor and Council will be partnering with Wallington Recreation for a Winter Festival.

Would like to provide insight that the roofing contractor provided the proper 30-year warrantee. We can now move forward and release the performance bond.

ADMINISTRATOR REPORT

Went out to bid for Hathaway project and we were lucky that the bid came in under where our expectations were. We anticipate some usage of the 20% on change orders. Councilman Rachelski asked how we can protect ourselves from change orders; Borough Engineer outlined issues with the project and that their existing protections in place. Borough Administrator provided an overview of concerns brought to him by DPW Superintendent Ray Dynes. Reiterated that the condition on Hathaway Street where not addressed. Borough Engineer provided an over view of some items he found during his walk through that can potentially generate issues. Borough Engineer provided a detailed overview of two major projects. Councilman Rachelski brought up issues about spending, the rate of spending, and despite record low interest rates, is this sustainable. A discussion took place on a way to protect our roads from being opened shortly after they are paved. Will look into road opening ordinance.
