COMMITTEE REPORTS

Councilman Androwis would like to invite everyone to a Tree Planting event on Saturday, October 20th at 9AM. Multiple organizations, Borough employees and school children will be present. Planting will take place at the Liberty Park in Wallington.

Councilman Androwis also spoke about Shade Tree Commission and future ideas.

Borough Engineer - David Juzmeski presented his engineering report.

- 1. Wallington Fire Department Roof replacement project is on the way.
- 2. Sidewalk Project on King Street it is half way done on both sides.
- 3. Mt. Pleasant Playground and Crescent Road Park Project bids were received on September 26th and exceed what was allocated for the project. Mr. Juzmeski suggested rejecting the bids and changing the scope of the project, including purchase of equipment through state contracts and use Department of Public Works to help remove existing playground equipment. Council members questioned the cost of the project, which grants are included, bonding and changes to the scope of the project. Discussion followed. Mr. Juzmeski answered all the questions and explained the new plan for the project.

Motion by Brunacki, Seconded by Olkowski, to reject the bids and authorize readvertisement on the revised scope of the project, subject to committee approval. Roll Call: All Ayes

- 4. Civic Center Generator pre-construction meeting was on September 20th, generator was ordered, there is a deadline from FEMA, December 30th, extension might be in order.
- 5. Additional PSE&G lighting documents need to be signed allowing increase in the billing for additional lights.
- 6. 54 Union Boulevard it was discussed how to proceed with the project.
- 7. FY2019 NJDOT Municipal Aid Applications Hathaway Street, Curie Avenue, Spring Street and Chestnut Street, an application will be filed by the grant writer. Councilman Androwis questioned if Jordan Avenue can be added to the grant application, streets are bad. Mr. Juzmeski needs to check with the grant writer to see if the resolution can be updated to include mentioned streets.

- 8. Spring Street Pump station Mr. Dynes is coordinating the project.
- 9. Emergency Vehicle traffic control at Paterson /Johnson Intersection it was confirmed that additional signage as requested will be added.
- 10. Additional Stop sign installation at Wallington Avenue/Union Boulevard accident reports were sent, traffic volume does not warrant for additional traffic sign on the county road.
- 11. Wallington Avenue water-main improvement Grant writer needed additional information, Councilman Olkowski is following up with the water bank, curbs and sidewalks, soft cost could be included in the application, the bank is willing to meet with the small committee to discuss. Councilman Olkowski would like to form a committee to be involved in the meeting with the bank and following up with the project. Mayor suggested for Administrator Mr. Polce to coordinate the meeting.
- 12. 2017-2018 Municipal Road Program Jacob Street is under construction, project will be closed out soon. Willow Avenue, Spring Street and Spring Court is out to bid, expected date for the bid October 23, 2018. Intention is to do all three streets as long as the bids come within the budget. Currie Avenue received CDBG funding, waiting for directions on how to proceed with the project. Councilman Olkowski questioned funding and how does it work, Councilwoman Dabal was asking if funds could be reprogrammed to different streets.
- 13. State aid improvement of Park Row it will get closed out, striping has to be redone because of the parking on the street.

Mayor Tomko brought up concerns about Reservoir Avenue and what is happening under the surface. Borough Engineer Mr. Juzmeski suggested televising of the water pipe and see what is going on there. Proposal for televising will be submitted for approval.

Motion by Brunacki, Seconded by Androwis, to approve televising of Reservoir Avenue and obtain three quotes not to exceed \$6,000.

Sprint wants to update equipment on their cell tower. All work is to be done within the existing fence. Borough Engineer Mr. Juzmeski stated there is no objection to what they are proposing from an engineering point of view. Mayor has to sign the proposed contract.
