# **OLD BUSINESS:**

- Councilwoman Ivanicki addressed Crossing Guard chain of Command protocol.
- Councilwoman Preinfalk advised that PSEG connected the gas line to the new library building but need to still install new meter. Once completed they can start moving in the new furniture. Estimated date is 3/11/24.

#### **NEW BUSINESS:**

- Mayor Dabal advised that she spoke with Ray Dynes at the DPW and requested he replaces the American Flag outside of the Civic Center be replaced. She also stated they are going to remove the sign from the outside wall, refinish the wood border, replace the glass and put it back up.
- Mayor Dabal requested Acting Clerk, Frank Belli to order business cards for Councilman Graham.

- Councilman Graham advised everyone that Recreation is having an Easter event at the Wallington High School 3/24/24 2-4pm.
- Councilwoman Preinfalk requested DPW refinish the pump house façade next to the new library building and discussed the possibility of a new brick campaign.
- Councilwoman Ivanicki requested Acting Clerk Frank Belli to move forward with the purchase of a time clock for the DPW employees.
- Councilman Androwis advised that PSEG changed 2 light poles in town and a transformer on Harrison Avenue with little to no service interruptions.
- Councilwoman Balik explained that the Board of Health and Rent Leveling meetings were cancelled. The shade tree meeting was rescheduled to February 27th. The following DPW work was performed since January, 2024. Replaced 10 water meters, rebuild eight storm drains. There are many collapsed storm drains in the town. Numerous potholes were repaired. Rearranged file cabinets at the Borough Hall. Repaired water main break on Strong Street. Replaced outdated street signs. Assisted with loading items and has been ongoing sweeping the streets. Right now, the sweeper is winterized and parked on latex property so they can rearrange the DPW garage for snow events. Salted, plowed, shoveled through three snowstorms. One truck is out for repair and needs a new engine. We installed a few new garbage cans, cleaned up the sign by the pallet property. Once it's easy to access and safe, we will remove the sign. And Ray just wanted to let you guys know that we have the opportunity to receive 50 tons of salt for free from the last storm, but we don't have enough room to put it on the current salt shed and the approximate cost of that salt that we would get for free is 4,000. Okay and Sue, you asked about some of the stuff that was left behind in the old library. So, Ray said it's in storage and if the library ever needs it, it's stored properly.
- Jen Appice stated that she spoke to Robert Esposito from Bergen County Division of Community Development. Wallington was one of the only municipalities that received a grant, and the Borough will use it to replace the HVAC unit for 202 firehouse.
- The Mayor stated she attended a meeting with the Emergency Squad to inform them about the insurance mandated volunteer handbook and she also discussed that any potential alteration to the to any municipal owned building has to be discussed with the Borough Administrator and the construction official prior to construction. EMS Captain Ed DiGiorgi apologized on behalf of himself and President Fehl and stated that he should have informed them and will renovate the area asap.
- Mayor finished by discussing the changing traffic pattern around Jefferson Annex to alleviate the buildup of traffic on Paterson Avenue.

#### **ADJOURNMENT**:

There being no further business before the Mayor and Council, Mayor Dabal requested a motion for adjournment.

Councilwoman Balik motioned for adjournment of the meeting, seconded by Councilman Graham.
