**BOROUGH OF WALLINGTON – ORDINANCE #2011-9
AN ORDINANCE TO AMEND CHAPTER 197 OF THE CODE**

OF THE BOROUGH OF WALLINGTON

BE IT ORDAINED by the Mayor and Council of the Borough of Wallington, State of New Jersey that Chapter 197 of the Code of the Borough of Wallington entitled "Garage Sales" shall be amended as follows:

SECTION 197-4. Number of sales per year; duration.

The registered owner of a property and occupants of the premises may have two (2) garage or yard sales per year. Each sale may not consist of more than two (2) consecutive days.

The Mayor & Council may designate one (1) day a year when all registered property owners and occupants of the premises may conduct a garage sale on the same date. All registered property owners and occupants of the premises shall be entitled to conduct a garage sale on that date even if they had previously utilized the two (2) sale limitation.

SECTION 197-5. Sales on apartment complex premises.

Garage or yard sales are not permitted on the premises of apartment complexes unless permitted by the apartment owner.

SECTION 197-6. Signs.

B. Only five (5) signs are permitted for a garage or yard sale.

C. A garage or yard sale sign cannot measure more than two (2) feet wide by two (2) feet high,

D. No garage or yard sale signs can be posted on trees, poles, or shrubs.

SECTION 197-13. License Fee.

The fee for a garage sale license shall be five dollars (5). Any bona fide charitable, educational, cultural or governmental institution or organization may apply to the Mayor & Council for an exemption from the filing fee. There shall be no fee for a sale conducted on the date of the town wide sale.

SECTION 197-14. Violations & Penalties.

Any violation of this chapter shall, upon conviction, be punishable by a fine not exceeding seventy-five dollars (\$75.). For a second or any other subsequent violation, the violation shall be punishable by a fine not exceeding one hundred fifty dollars (\$150.).

If any section, part of any section, or clause or phrase of the Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining provisions of this Ordinance. The Governing Body of the Borough of Wallington declares that it would have passed the Ordinance and each Section and Sub-section thereof, irrespective of the fact that any one or more of the Sections, sub-section, sentences, clauses or phrases may be declared unconstitutional or invalid.

This Ordinance shall take effect immediately upon passage and publication according to law.

All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed as to such inconsistencies.
