The second matter of business was a Waiver of Site Plan Jose S. Ventura - 417 Paterson Ave, Wallington NJ 07057; Block 54 Lot 10

Edwin Lizama, Audel Ventura testified. The applicant seeks approval to use the space as a restaurant, which is the same use the property had formerly been used for. The applicant testified that he is not proposing any changes

to the exterior of the building, but will be performing some repairs and modification inside. The Applicant testified that there will be a dumpster on site and garbage enclosure will be fixed. There will be six employees on site. The Applicant testified they would be open Monday through Sunday between 11:00 a.m. and 10:00 p.m. Landscaping needs to be updated around the property, tree stump needs to be removed and new tree planted. Board also requested that the street lights would be placed on the curb. The Applicant agreed to install a Knox Box if one is not already on the building
